Preamble

The Memorandum of Understanding (MOU) is between Internal Quality Assurance Cell, SKR & SKR Government College for Women (A), Kadapa-516001, YSR Dist., A.P., and Government Degree College, Porumamilla-516193, Kadapa Dist, AP, Kadapa here after referred as GDC, Porumamilla. This MoU is effective from 11th November of the year 2023

SKR & SKR Government College for Women(A), Kadapa Dist., A.P. is an Autonomous Educational Institution offering UG and PG Programs and Government Degree College, Porumamilla is also an Educational Institution offering UG Programs. Now therefore, the parties here to have agreed to enter into a Memorandum of Understanding (MoU) considering the long-term benefits of sharing the knowledge between the parties and establish a vibrant academic collaboration by undertaking joint activities in their respective fields of Research and other useful academic activities. Both parties recognize their strengths in education and research in one or more disciplines of science, commerce and social sciences, and their mutual interest in engaging themselves in academic cooperation.

Objectives

The goal is to foster collaboration to provide opportunity to facilitate sharing of knowledge & academic facilities to the students and teaching, non-teaching staff on the basis of reciprocity, best effort, mutual benefit, and frequent interactions.

The following mutually benefited points are agreed by and between the parties as described under.

1. To share knowledge & academic facilities for academic and research activities
2. To exchange information on teaching, learning material and other literature relevant to their educational and research programmes, while respecting each other's intellectual property and other rights.
3. To jointly organize seminars ,conferences, or workshops, Training Programmes on topics of mutual interest and to invite each other's faculty to participate therein
4. To jointly propose and engage in research or training programmes and to invite each other's faculty to participate therein.
5. To share of human resource such as Teaching & Non-Teaching Staff for limited period of time for the purpose of academic cooperation.
6. To perform collaborative research work and publish article for mutual benefit.
7. To arrange Guest Lectures, invited talks, Resource Person in Events to the faculty of Partner institution.

Financial Consideration:

Any cost involved in the academic or research activity will be borne by SKR & SKR Government College for Women (A), Kadapa Dist., or GDC, Porumamilla or both as per their institutional policies.

Confidentiality

To exchange information on teaching, learning material and other literature relevant to their educational and research programs, while respecting each other's intellectual property and other rights.

However, in the event of disclosure proprietary information to each other, it shall be disclosed pursuant to separate written agreement.

Each Party thereof re agrees that the contents of this MoU and the negotiations in relation to any future proposal remain strictly confidential.

Tenure and Termination

This MoU will take effect from the date it assigned by representatives of the two institutions. It will remain valid for Three years, and may be continued there after suitable review and agreement.
